(E) EDUCATION

NATURE OF WORK:

(S) CLINICAL/TECHNICAL SPECIALIST

NATURE OF WORK:

- Designs and deploys front-end templates/web pages for health sciences related applications.
- Troubleshoots issues, builds system dictionaries, coordinates consensus on data elements, performs test codes, and creates customized reports and queries.

(R) RESEARCH AND DEVELOPMENT

NATURE OF WORK:

Jobs matched to this profile have delegated responsibility and accountability for the provision of formal research and development by planning, developing and coordinating research and development activities for the profession.

Illustrative Responsibilities:

- Assigned accountability to plan, develop, coordinate, deliver outcomes of research, and development activities within the designated profession.
